- 5. Within one week of application approval, the applicant must provide a certified cheque payable to SYWC in the amount of ten thousand dollars (\$10,000) as a membership fee. This amount represents the subscriber's share of the current value of the SYWC infrastructure. The certified cheque will be held in trust by the corporation's solicitor until such time as the connection to the residence is complete and installed to SYWC standards and specifications and within the time frame outlined. Failure to comply with the above may result in cancellation of the Application, at the sole discretion of the corporation, with a one thousand (\$1000) dollars administrative penalty being applied and the remaining funds held in trust will be returned to the subscriber.
- 6. Applicant is solely responsible for all costs of service connection installation, from the main to the residence with the exception of the meter manifold, curb stop and box materials which will be supplied by SYWC. Installation must be in accordance with SYWC specifications, installed by a SYWC approved Contractor and inspected by SYWC.
- 7. The water service provided is a drip system only and a holding tank and pressure system must be installed in the residence by the owner to provide household water pressure.
- **8.** The Applicant must agree and sign the Subscriber Water Supply Agreement upon acceptance of their application.
- **9.** The Applicant agrees to be subject to all of the Bylaws, Rules and Regulations of the Corporation.
